By using the Services, you consent to the collection, use and disclosure of your personal information as described in this Privacy Policy. If you do not agree to this Privacy Policy, then please do not use our Services.



## PERSONAL INFORMATION

Personal information is information or an opinion that identifies you or that will enable your identity to be reasonably ascertained (including your name and contact details such as your residential or postal address, email address, or your telephone number).

Please note that any information which cannot be reasonably linked to your identity (e.g. IP address, browser information, favourite websites) does not constitute personal information and is not regulated by the Privacy Act.

Light Armour collects information about you and its other customers using the Services and the information collected may vary depending on your particular interaction with Light Armour, but will be limited to the information necessary to record and manage Light Armour 's interaction with you or as permitted or required by law.

The personal information that Light Armour collects is primarily related to its provision of the Services and by providing such personal information, you consent to your personal information being collected, stored, used and disclosed in accordance with this Privacy Policy.

## INFORMATION COLLECTION

## 1. Information You Provide to Us.

We only collect personal information from you when you provide it to us, such as when you:

- (a) place an order;
- (b) complete a survey or product review;
- (c) participate in one of our promotions; or
- (d) contact us.

The personal information we collect from you may include your name, age, mailing address, daytime telephone number, mobile phone number, e-mail address, and payment information. If you use a third party login to register or otherwise link to us, we may receive certain information about you from the third party (such as a social network) and privacy settings on that third party service.

The provision of your personal information is entirely voluntary and you are entirely free to decide whether or not to give your personal information to us. However, you acknowledge and agree that if you do not provide sufficient or adequate information to us, we may not be able to provide you with a full range of Services or may not be able to fully assist you with your enquiry.

## 2. Information We Automatically Collect.

We may use cookies, web beacons, pixel tags, log files, or other technologies to automatically collect certain information when you use our Website or App, or interact with our emails or advertisements on our Website, our App, or other websites. A cookie is a small data file that is sent to your browser from a web server and stored on your computer's hard drive. Please note that our cookies do not store or collect any personal information about you nor do they personally identify you (though they do identify a user's browser). We may automatically collect information such as your IP address, geolocation data, unique user ID, mobile phone model, operating system, and carrier, and Internet Service Provider. We also may collect information about your use of our Services, such as the time you spend using the Website or App, the number of times you return, whether you click-through, open, or forward links, emails, and advertisements and other Service usage data.

These technologies, such as cookies, web beacons, pixel tags, log files, allow us to keep track of your order as you shop on our Website or App, recognise users when they visit, and provide customers with information and advertising that is more relevant to them. If you order from us, we may use cookies or other technologies to monitor and maintain information about how you use our Services and what you buy. If you do not buy from us, we may monitor and maintain information about your use in order to improve your shopping experience and provide you with more relevant content and advertising.

## 3. Tracking Options.

Most browsers are set to accept cookies automatically. However, you may adjust your browser settings to limit certain tracking or to decline cookies, but by doing so, you may not be able to use certain features on the Services or take full advantage of our offerings. Even without a cookie, you can still take advantage of most of the features of our Website, including making a purchase.

# **Strictly Necessary Cookies**

These cookies are necessary for the website to function and cannot be switched off in our systems. They are usually only set in response to actions made by you which amount to a request for services, such as setting your privacy preferences, logging in or filling in forms.

You can set your browser to block or alert you about these cookies, but some parts of the site will not then work. These cookies do not store any personally identifiable information.

## 1. Third Party Service Providers.

We may use third party service providers to provide you with more relevant online advertising based on your activities on our Website and third party sites. On our website we use the services of CloudFlare, Poll AnyApp, Google, GStatic, NR Data, Powr.IO and Wix for analysing aggregated non-personalised data. Light Armour will not (and will not allow any third party to) use these services to track or collect or otherwise process any personal information of users of its Website. For certain service providers, such as social media platforms, and on your mobile device, you can adjust your privacy and advertising settings to limit your tracking for advertising or control whether you receive more relevant advertising.

We will not identify users or facilitate the merging of personal information with nonpersonal information collected through any Google advertising product or feature unless we have your explicit notice and your prior affirmative (i.e., opt-in) consent to that identification or merger. Irrespective of your consent, we will not attempt to disaggregate data that Google reports in aggregate.

## 1. Combination of Information.

We may also combine the information we receive from and about you, including the information you provide to us on one of the Services, information we automatically collect (as explained above), and information provided or collected offline when you shop in our Stores.

#### **INFORMATION USE**

We may use the personal information we collect from and about you for the following purposes:

- 1. To process your orders, contact you concerning the status of an order, answer any of your questions, or otherwise contact and communicate with you;
- To provide you with a quick and simple checkout experience (if you choose to register on our Website or App);
  - 3. To allow you to participate in promotions;
- 4. To help us learn more about our Website visitors, App users and customers and to improve their shopping experience and our business;
- 5. To address problems with the Service, our business or our products and services and to protect the security of the Website and our business;
  - 6. For payment processing and authorisation, fraud protection and credit risk reduction, website evaluation and data analysis, and distributing marketing and promotional material;
  - 7. To comply with the law, to respond to governmental inquiries or requests, to enforce our policies, or to protect our or others' rights, property, or safety;

    8. Otherwise, as described to you at the point of collection.

#### INFORMATION DISCLOSURE

We may disclose the information we collect from and about you as follows:

1. Amongst Light Armour ONLY (Australia)

2. To our service providers, if the disclosure will enable them to perform a business, professional, or technical support function for us. Our service providers will be under strict obligations of confidentiality and will be subject to the Australian privacy laws, including the Privacy Act;

3. To carefully-selected third party partners,4. Otherwise, with your consent.

Any personal information or content that you voluntarily upload or submit for public posting to the Service becomes publicly available and can be collected and used by others. It is a violation of the Service's Terms & Conditions for you to post any content that requests personal information from others on the Service.

As with any business, it is possible that as our business develops, we might sell or buy online stores or other assets. In such transactions, information about customers often is among the transferred assets. Accordingly, in the unlikely event that our company or substantially all of our assets are acquired by a third party, such information may be one of the transferred assets. Should such a sale or transfer occur, we will use reasonable efforts to try to require that the transferee use personal information provided through the Services in a manner that is consistent with this Privacy Policy. We may share aggregate, de-identified information about Website users with third parties.

#### **USE OF COOKIES**

We may use cookies and other technologies like them to make our Website better. You can read about our use of cookies and how to limit or decline them in the Section on "Information Collection" and specifically paragraph "2. Information We Automatically Collect" and paragraph "3. Tracking Options".

#### **CHANGES TO OUR PRIVACY POLICY**

We may amend this Privacy Policy at any time. If we make any material changes in the way we collect, use, and/or share your personal information, we will notify you by sending you an e-mail at the last e-mail address that you provided us, and/or by prominently posting notice of the changes on the Website or App. Any material changes to this Privacy Policy will be effective upon the earlier of thirty (30) calendar days following our posting of the notice of changes.

#### **CHILDREN'S PRIVACY**

Light Armour is concerned about the safety of children when they use the internet. We do not direct the Website or App to, nor do we knowingly collect any personal information from, children under the age of sixteen. We believe that children should get their parent's consent before giving out personal information. If you have not yet reached the age of 16 years, your parents will have to consent to submit personal information to us, including placing an order on the Website.
